SEC to Return Over \$550,000 to Members in December!

At the September 2022 Board Meeting, the SEC Trustees approved a General Retirement of Patronage Capital for the 1996 operating year in the amount of \$550,916.30. Patronage Capital, also known as Capital Credits, is the margin or profit resulting from the annual operations of SEC.

Your SEC is a non-profit cooperative whose members share in the ownership, operations, and prosperity of the cooperative. The return of Capital Credits reflects one, identified as "Member Economic Participation," of the seven Cooperative Principles by which SEC operates. This participation by the Members is unique to electric cooperatives because investor-owned and municipal electric companies do not pay Capital Credits or "dividends" back to their customers.

SEC "assigns" margins or allocations to each electric account on a pro-rata basis each year. The Board of Trustees determines if the retirement, or refund of Capital Credits, back to Members is feasible. Trustees consider the overall financial condition of SEC when deciding whether, when, and in what amount to return Capital Credits to Members. Capital Credits are returned on a "first-in, first-out" basis, which means that the members that have been with SEC the longest will be the first to receive their Capital Credits from SEC.




SEC Trustee Leroy Anaya from District III presents the Tri-State Donation to Socorro Historical Society President, Charles Zimmerly


