### U.S. Representative Xochitl Torres Small visits SEC

Your SEC was recently honored to have U.S. Representative Xochitl Torres Small of New Mexico's 2nd Congressional District visit us at our headquarters in Socorro. Rep. Torres Small recently received notification from the United States Department of Agriculture that SEC was approved for a loan of \$28 million under the Rural Utilities Service (RUS) program for our new Construction Work Plan (CWP). As the CWP contains projects identified for "Smart Grid" implementation, Rep. Torres Small, called and asked for a meeting with SEC, in an effort to gain a better understanding as to how SEC would utilize these loan funds in the daily operations of a rural electric cooperative located in her district.

Joseph Herrera, General Manager, welcomed the opportunity to meet with Rep. Torres Small to explain the specifics of future system improvements as outlined in the CWP. Manager Herrera reviewed the largest project, the replacement of the 69 kV transmission line between Socorro and Magdalena, explaining this would include the addition of fiber optic cable, which would terminate at the Magdalena Substation. Another planned project is the addition of several poles, to be inset in long spans of the distribution lines, which will allow for SEC to extend fiber cable to our Bernardo and Burris Substations located in Socorro County and Valencia County, respectively.

These proposed fiber line installations will be used for SEC's internal purposes by increasing communications capabilities between SEC's substations to support future Smart Grid technologies. This fiber will also enhance the performance of the recently completed Automated Metering Infrastructure Project. Manager

Manager Herrera explained how the proposed fiber installations for SEC's electrical operations will be an island unto itself. In order to provide broadband services to others, the fiber system would need to extend to Albuquerque or El Paso to gain access to the Internet hubs located there, or SEC would have to pay an existing Internet provider for access. SEC would also have to restate our existing rights-of-ways to allow for the inclusion of broadband services.

Manager Herrera continued that in 2018, SEC's Board and Management researched the Connect America Fund program, offered by the FCC, that would supplement the cost of providing broadband to underserved areas in rural America. The FCC Broadband Service maps at that time showed our service area was not underserved, so no grants were available for

providers per the guidelines of the program. The current abundance of existing broadband providers in our service area and the unfavorable economics for serving the very rural population without financial assistance, prompted SEC's Board to "stay with what we know best" in providing reliable, affordable electricity.

SEC really appreciates the time Rep. Torres Small took to meet with us. This provided SEC an opportunity to describe the challenges in serving 11,000 square miles of a very rural area with only 3.8 connected meters per mile of power line.



# SEC's Foundation Support of 4-H Clubs Continues ......

# NOTICE Winter Moratorium Protection

Protection from winter shut-off begins November 15, 2020.

To avoid potential disconnection of services, please contact the human services department at **800-283-4465** or the appropriate tribal or pueblo entity for eligibility information for low income heating energy assistance program (LIHEAP).

Your service will not be disconnected from November 15, 2020, through March 15, 2021, if you meet the qualifications of LIHEAP and have no past due amounts or you remain current on any settlement or installment agreement for amounts due as of November 15, 2020.

Members of New Mexico tribes or pueblos who need help with translation or with other matters may contact the commission's consumer relations division at (888)427-5772, who will contact the appropriate tribal or pueblo official for assistance.

### 2019 Capital Credit Allocations

The allocations of the 2019 margins will be reflected on the August and September bills received by all active accounts.
